## **DECISION**

Dispute Codes OPR, MNR, MNDC, FF

## **DECISION AND REASONS**

This matter dealt with the Landlord's Application for an order of possession, a monetary order for unpaid rent and for money owed or compensation for damage or loss and to recover the filing fee for this application.

Rule 10.1 of the Residential Tenancy Branch Rules of Procedure provides as follows:

**Commencement of the hearing** The hearing must commence at the scheduled time unless otherwise decided by the dispute resolution officer. The dispute resolution officer may conduct the hearing in the absence of a party and may make a decision or dismiss the application, with or without leave to re-apply.

The hearing started at 9:30 a.m. as scheduled, however by 9:45 a.m., neither the Landlord nor the Tenant had dialled into the conference call. Accordingly, in the absence of any evidence or submissions I order the application dismissed with leave to reapply. I make no findings on the merits of the matter. Leave to reapply is not an extension of any applicable limitation period.

## Conclusion

The Landlord's application is dismissed with leave to reapply.
