DECISION

Introduction

This hearing was convened in response to an application by the landlord pursuant to the *Residential Tenancy Act* (the Act) for Orders as follows:

1. An Order of Possession - Section 55;
2. A Monetary Order for unpaid rent - Section 67;
3. An Order to recover the filing fee for this application - Section 72.

I accept the landlord's evidence that despite the tenant having been served with the application for dispute resolution and notice of hearing by registered mail – sent on on August 29, 2011- in accordance with Section 89 of the Residential Tenancy Act (the Act) the tenant did not participate in the conference call hearing.

The landlord was given full opportunity to be heard, to present evidence and to make submissions.

Issue(s) to be Decided

Is the notice to end tenancy valid?

Is the landlord entitled to an Order of Possession?

Is the landlord entitled to the monetary amounts claimed?

Background and Evidence

The tenancy began on April 01, 2011. Rent in the amount of \$2500 is payable in advance on the first day of each month. At the outset of the tenancy, the landlord collected a security deposit from the tenant in the amount of \$1250. The tenant failed to pay all rent payable in the month of August 2011 (\$690) and on August 15, 2011 the landlord served the tenant with a notice to end tenancy for non-payment of rent. The tenant further failed to pay any rent in the month of September 2011. The quantum of

the landlord's monetary claim is for the unpaid rent in the total of **\$3190**, plus late fees of **\$20** per month for August and September 2011, in accordance with the terms of Tenancy Agreement.

Analysis

Based on the landlord's testimony I find that the tenant was served with a notice to end tenancy for non-payment of rent and I find the notice to be valid. The tenant has not paid the outstanding rent and has not applied for Dispute Resolution to dispute the notice and is therefore conclusively presumed to have accepted that the tenancy ended on the effective date of the notice.

Based on the above facts I find that the landlord is entitled to an **Order of Possession**.

I also find that the landlord has established a monetary claim for **\$3230** in unpaid rent and late fees. The landlord is also entitled to recovery of the \$50 filing fee, for a total entitlement of **\$3280**. The **security deposit** held by the landlord will be off-set from the award made herein.

Calculation for Monetary Order

Rental Arrears	\$3190.00
Late fee X 2	\$40.00
Filing Fees for the cost of this application	50.00
Less Security Deposit and applicable interest <i>to date</i>	-1250.00
Total Monetary Award	\$2030.00

Conclusion

I grant an Order of Possession to the landlord **effective two (2) days from the day the order is served**. The tenant must be served with this **Order of Possession**. Should the tenant fail to comply with the order, the order may be filed in the Supreme Court of British Columbia and enforced as an order of that Court.

I order that the landlord retain the **deposit** and interest of \$1250 in partial satisfaction of the claim and I grant the landlord an order under Section 67 of the Act for the balance due of **\$2030**. If necessary, this order may be filed in the Small Claims Court and enforced as an order of that Court.

This decision is made on authority delegated to me by the Director of the Residential Tenancy Branch under Section 9.1(1) of the *Residential Tenancy Act*.
