<u>Introduction</u>

This hearing dealt with an Application for Dispute Resolution by the tenant to cancel a Ten-Day Notice to End Tenancy for Unpaid Rent or Utilities.

The applicant tenant did not appear, but the respondent landlord was present.

As the applicant tenant did not appear, the tenant's application requesting an order to cancel the Ten-Day Notice must be dismissed.

At the hearing the landlord made a request for an order of possession. Under the provisions of section 55(1) of the Act, upon the request of a landlord, I must issue an order of possession when I have upheld a notice to end tenancy.

Conclusion

The tenant's application is dismissed without leave to reapply.

I hereby issue an Order of Possession in favour of the landlord effective immediately after service to the tenant. The tenant must be served with the order of possession. Should the tenant fail to comply with the order, the order may be filed in the Supreme Court of British Columbia and enforced as an order of that Court.
