Introduction and Analysis

This hearing was convened as the result of the landlord's application for dispute resolution under the Residential Tenancy Act (the "Act") for an order of possession and to recover the filing fee for this application.

The conference call hearing started at 2:30 p.m. as scheduled; however by 2:40. p.m., neither the landlord nor the tenant had dialled into the hearing.

Conclusion

Therefore, in the absence of both the applicant and the respondent, I dismiss the landlord's application, with leave to reapply.

I make no findings on the merits of the matter. Leave to reapply is not an extension of any applicable limitation period.
