DECISION

<u>Introduction</u>

This hearing was convened as a result of the landlord's application for dispute resolution seeking remedy under the *Manufactured Home Park Tenancy Act* (the "Act"). The landlord applied for an order of possession for unpaid site rent, for a monetary order for unpaid site rent, and to recover the filing fee.

The tenants did not attend the hearing. The landlord did attend the hearing, and requested to **withdraw his application in full** as he has settled his dispute with the tenants. Therefore, I make no findings on the merits of the matter.

The landlord is at liberty to reapply. This decision does not extend any applicable time limits under the *Act*.

This decision is final and binding on the parties, unless otherwise provided under the Act, and is made on authority delegated to me by the Director of the Residential Tenancy Branch under Section 9.1(1) of the *Manufactured Home Park Tenancy Act*.
