## **DECISION**

**Dispute codes:** ERP FF LAT LRE MNDC OLC PSF

Pursuant to the *Residential Tenancy Act*, R.S.B.C. and amendments thereto I was designated to hear this matter under section 58. This hearing dealt with an application pursuant to the *Residential Tenancy Act* SBC 1996 ("the *Act*") in respect of the abovenoted tenancy.

Rule 10.1 of the Rules of Procedure provides as follows:
