## **DECISION**

Dispute Codes MNR, OPR

This matter was conducted by way of Direct Request Proceeding, pursuant to section 55(4) of the Act, and dealt with an Application for Dispute Resolution by the landlord for an Order of Possession and a monetary order due to unpaid rent.

On a Direct request application the landlord is required to submit the following evidentiary material:

- A copy of a residential tenancy agreement which was signed by the parties.
- A copy of a 10 Day Notice to End Tenancy for Unpaid Rent, which includes the direct request explanation.
- Proof of service of the 10 day Notice to End Tenancy as either a registered mail
  receipt or written receipt signed by the tenant or witnessed by a third-party
  confirming the notice was served.

And before the direct request proceeding can take place the landlord must also supply:

 A copy of the Proof of Service of the Notice of Direct Request Proceeding for each tenant;

On this application the landlord has provided the first three items above; however the Proof of Service of the Notice of Direct Request Proceeding supplied by the landlord states that the Notice of Direct Request Proceeding was served on August 30, 2013, however since today is only August 23, 2013, that is not possible.

Therefore since the landlord is not supplied valid proof of having served the Notice of

Direct Request Proceeding I'm not willing to proceed with this hearing.

Conclusion

This application is dismissed with leave to reapply.
