Introduction and Analysis

This Hearing was scheduled to hear the Tenants' application for return of the security deposit.

This application was scheduled to be heard via teleconference on October 1, 2013, at 3:00 p.m. By 3:10 p.m., neither party had signed into the teleconference.

Rule 10.1 of the Residential Tenancy Branch Rules of Procedure provides as follows:

Commencement of Hearing The hearing must commence at the scheduled time unless otherwise decided by the arbitrator. The arbitrator may conduct the hearing in the absence of a party and may make a decision or dismiss the application, with or without leave to re-apply.

As neither party attended the conference, I dismiss the Tenants' application with leave to re-apply. This does not extend any existing time limits that may apply.
