## **DECISION**

## **Introduction and Analysis**

This Hearing was scheduled to hear the Landlord's application for an Order of Possession and a monetary award.

This application was scheduled to be heard via teleconference on October 10, 2013, at 3:00 p.m. By 3:10 p.m., neither party had signed into the teleconference.

Rule 10.1 of the Residential Tenancy Branch Rules of Procedure provides as follows:

**Commencement of Hearing** The hearing must commence at the scheduled time unless otherwise decided by the arbitrator. The arbitrator may conduct the hearing in the absence of a party and may make a decision or dismiss the application, with or without leave to re-apply.
