DECISION

Dispute Codes: CNE, LAT, FF

This hearing dealt with an application by the tenant for an order to set aside a notice to end tenancy for end of employment, for authorization to change the locks and for the recovery of the filing fee. This matter was set for a conference call hearing at 1:00 p.m. on this date. As of 1:10 p.m., the applicant/tenant had not called into the conference call. The respondent/landlord called in.

During the waiting period, the landlord made an oral request for an order of possession in the event that the tenant's application was not successful. Since the applicant did not call into the conference call, his application is dismissed without leave to reapply and the notice to end tenancy is upheld.

The landlord made a request under section 55 of the legislation for an order of possession. Under the provisions of section 55, upon the request of a landlord, I must issue an order of possession when I have upheld a notice to end tenancy. Accordingly, I so order. Should the tenant fail to comply with the order, the order may be filed in the Supreme Court of British Columbia and enforced as an order of that Court.

Conclusion

The notice to end tenancy is upheld and I grant the landlord an order of possession effective two days after service on the tenant.
