## **DECISION**

Dispute Codes: CNR OPR

Pursuant to the *Residential Tenancy Act*, R.S.B.C. and amendments thereto I was designated to hear this matter under section 58. This hearing dealt with an application pursuant to the Residential Tenancy Act SBC 2002 ("the Act") in respect of the abovenoted tenancy and was set for 1:00 p.m. on April 3, 2014. ## Rule 10.1 of the Rules of Procedure provides as follows:
