## **Decision**

### **Introduction**

This hearing dealt with an Application for Dispute Resolution by the landlord for an Order of Possession based on the Notice to End Tenancy for Unpaid Rent and a monetary order for rental arrears.

Although served with the Application for Dispute Resolution and Notice of Hearing in person on February 25, 2014, the tenant did not appear.

### **Issue(s) to be Decided**

Is the landlord entitled to an Order of Possession based on the 10-Day Notice to End Tenancy for Unpaid Rent?

Is the landlord entitled to monetary compensation for rental arrears owed?

### **Background and Evidence**

The landlord submitted into evidence a copy of the 10-Day Notice to End Tenancy dated February 12, 2014 with effective date of February 22, 2014 and proof of service. The landlord testified that the tenancy began on December 31, 2013, at which time the tenant paid a security deposit of \$325.00 and the current rent is \$650.00 per month.

The landlord testified that the tenant failed to pay \$650.00 rent owed for February and a 10-Day Notice to End Tenancy for Unpaid Rent was served.

The landlord testified that the tenant did not pay the arrears and failed to pay \$650.00 rent for March 2014. The landlord is claiming compensation of \$1,300.00.

The landlord testified that, although the tenant vacated the unit at the end of March 2014 and the landlord has requested an Order of Possession because the tenant has not yet returned the keys.

### **Analysis**

Based on the testimony of the landlord, I find that the tenant was served with a Notice to End Tenancy for Unpaid Rent in person. The tenant has not paid the arrears and did not apply to dispute the Notice and is therefore conclusively presumed under section 46(5) of the Act to have accepted that the tenancy ended on the effective date of the Notice. Based on the above facts, I find that the landlord is entitled to an Order of Possession.

I find that the landlord has established a total monetary claim of \$1,350.00, comprised of \$1,300.00 accrued rental arrears and the \$50.00 fee paid by the landlord for this application. I order that the landlord retain the tenant's security deposit of \$325.00 in partial satisfaction of the claim leaving a balance due of \$1,025.00.

I hereby grant the Landlord an order under section 67 for \$1,025.00. This order must be served on the Respondent and is final and binding. If necessary it may be filed in the Provincial Court (Small Claims) and enforced as an order of that Court.

I hereby issue an Order of Possession in favour of the landlord effective two days after service on the tenant. This order must be served on the Respondent and is final and binding. If necessary it may be filed in the Supreme Court and enforced as an order of that Court.

### **Conclusion**

The landlord's application is successful and the landlord is granted a monetary order for rental arrears and an Order of Possession.
