A matter regarding CENTURY 21 PERFORMANCE REALTY AND MANAGEMENT and [tenant name suppressed to protect privacy]

DECISION

Dispute Codes: AAT RR OPT PSF FF

Pursuant to the *Residential Tenancy Act*, R.S.B.C. and amendments thereto I was designated to hear this matter under section 58. This hearing dealt with an application pursuant to the *Residential Tenancy Act* SBC 2002 ("the Act") in respect of the abovenoted tenancy and was set for 9:00 a.m. on December 4, 2014. By 9:15 a.m., no one had attended the conference call.

Rule 10.1 of the Rules of Procedure provides as follows:

10.1 Commencement of the hearing: The hearing must commence at the scheduled time unless otherwise decided by the arbitrator. The arbitrator may conduct the hearing in the absence of a party and may make a decision or dismiss the application, with or without leave to re-apply.
