A matter regarding WIDSTEN PROPERTY MGMT INC and [tenant name suppressed to protect privacy]

DECISION

<u>Dispute Codes</u> OPR & MNR

<u>Introduction</u>

This matter was conducted by way of Direct Request Proceeding, pursuant to section 55(4) of the *Residential Tenancy Act* (the *Act*), and dealt with an Application for Dispute Resolution by the landlord for an Order of Possession and a Monetary Order due to unpaid rent.

The Direct Request process is a mechanism that allows the landlord to apply for an expedited decision without a participatory hearing. As a result, the landlord must follow and submit documentation **exactly** as the *Act* prescribes and there can be no omissions or deficiencies within the written submissions that are left open to interpretation or inference.

The landlord submitted a signed Proof of Service of the Notice of Direct Request Proceeding which declares that on Jabuary 14, 2015 the landlord served the tenant with the Notice of Direct Request Proceeding by registered mail. Section 90 of the *Act* determines that a document is deemed to have been served on the fifth day after it was sent.

Based on the written submissions of the landlord, I find that the tenant has been served with the Dispute Resolution Direct Request Proceeding documents.

Background and Evidence

The landlord submitted the following evidentiary material:

- A copy of the Proof of Service of the Notice of Direct Request Proceeding for the tenant;
- A copy of a residential tenancy agreement which was signed by the parties on October 30, 2013 for a tenancy beginning November 04, 2013 for the monthly rent of \$700.00 due on the 1st of the month;
- A copy of a mutual agreement in which the second tenant named on the tenancy agreement was removed from the tenancy agreement on November 07, 2014
- A copy of a 10 Day Notice to End Tenancy for Unpaid Rent which was issued on,
 December 08, 2014 with an effective vacancy date of December 18, 2014 due to
 \$441.67 in unpaid rent;
- A copy of a Monetary Order worksheet which indicates that rent was owed of \$700.00, the tenant paid \$258.33 on December 02, 2014 leaving a balance outstanding of \$441.67.00.

Documentary evidence filed by the landlord indicates that the tenant had failed to pay the full rent owed for the month of December and that the tenant was served a 10 Day Notice to End Tenancy for Unpaid Rent which was posted on the door of the tenant's rental unit on December 08, 2014 and therefore is deemed served three days later.

The Notice states that the tenant had five days to pay the rent or apply for Dispute Resolution or the tenancy would end. The tenant did not apply to dispute the Notice to End Tenancy within five days.

<u>Analysis</u>

I have reviewed all documentary evidence and accept that the tenant has been served with Notice to End Tenancy as declared by the landlord. The Notice is deemed to have

been received by the tenant on December 11, 2014 and the effective date of the Notice

is amended to December 21, 2014 pursuant to section 53 of the Act. I accept the

evidence before me that the tenant has failed to pay the rent owed in full within the 5

days granted under section 46 (4) of the Act.

Based on the foregoing, I find that the tenant is conclusively presumed under section

46(5) of the *Act* to have accepted that the tenancy ended on the effective date of the

Notice.

Conclusion

I find that the landlord is entitled to an Order of Possession, pursuant to section 55 of

the Act, effective two days after service on the tenant. This Order must be served on

the tenant and may be filed in the Supreme Court and enforced as an Order of that

Court.

I find that the landlord is entitled to monetary compensation, pursuant to section 67 of

the Act, in the amount of \$441.67 for rent owed. This Order must be served on the

tenant and may be filed in the Provincial Court (Small Claims) and enforced as an Order

of that Court.

This decision is made on authority delegated to me by the Director of the Residential

Tenancy Branch under Section 9.1(1) of the Residential Tenancy Act.
