A matter regarding LOTS OF PROFITS LTD. and [tenant name suppressed to protect privacy]

DECISION

<u>Dispute Codes</u> OPR, MNR

<u>Introduction</u>

This matter proceeded by way of an *ex parte* Direct Request Proceeding, pursuant to section 55(4) of the *Residential Tenancy Act* (the "*Act*"), and dealt with an Application for Dispute Resolution by the landlord for an Order of Possession based on unpaid rent and a monetary Order.

The landlord submitted a signed Proof of Service of the Notice of Direct Request Proceeding which declares that on February 18, 2015, the landlord served the tenant with the Notice of Direct Request Proceeding via registered mail. The landlord provided a copy of the Canada Post Customer Receipt containing the Tracking Number to confirm this mailing. Section 90 of the *Act* determines that a document served in this manner is deemed to have been received 5 days after service.

Based on the written submissions of the landlord, and in accordance with sections 89 and 90 of the *Act*, I find that the tenant has been deemed served with the Direct Request Proceeding documents on February 23, 2015, the fifth day after their registered mailing.

Issue(s) to be Decided

Is the landlord entitled to an Order of Possession for unpaid rent pursuant to sections 46 and 55 of the *Act*?

Is the landlord entitled to monetary compensation for unpaid rent pursuant to section 67 of the *Act*?

Background and Evidence

The landlord submitted the following evidentiary material:

 A copy of the Proof of Service of the Notice of Direct Request Proceeding served to the tenant; Page: 2

 A copy of a residential tenancy agreement which was signed by the landlord's agent and the tenant on June 13, 2012, indicating a monthly rent of \$900.00 due on the first day of the month for a tenancy commencing on July 1, 2012;

- A Monetary Order Worksheet showing the rent owing during the portion of this tenancy in question, on which the landlord establishes a monetary claim in the amount of \$920.00 for outstanding rent owing for February 2015;
- A copy of a "Notice of Rent Increase" provided to the tenant, dated August 28, 2014, which detailed that monthly rent was increased from \$900.00 to \$920.00;
- A copy of a 10 Day Notice to End Tenancy for Unpaid Rent (the Notice) dated February 6, 2015, which the landlord states was served to the tenant on February 6, 2015 for \$920.00 in unpaid rent due on February, 2015, with a stated effective vacancy date of February 17, 2015; and
- A copy of the Proof of Service of the Notice showing that the landlord's agent served the Notice to the tenant by way of personal service via hand-delivery at 8:30 pm on February 6, 2015. The Proof of Service establishes that the service was witnessed by "TF" and a signature for TF is included on the form.

The Notice restates section 46(4) of the Act which provides that the tenant had five days to pay the rent in full or apply for Dispute Resolution or the tenancy would end on the effective date of the Notice. The tenant did not apply to dispute the Notice within five days from the date of service and the landlord alleged that the tenant did not pay the rental arrears.

Analysis

I have reviewed all documentary evidence and find that in accordance with section 88 of the *Act* the tenant was duly served with the Notice on February 6, 2015.

I find that the tenant was obligated to pay monthly rent in the amount of \$920.00, as the landlord has established that the monthly rent amount was raised in an appropriate manner from the initial amount of \$900.00, as established in the tenancy agreement, to the current amount of \$920.00. I accept the evidence before me that the tenant has failed to pay \$920.00 in rent for the month of February 2015. I find that the tenant received the Notice on February 6, 2015. I accept the landlord's undisputed evidence and find that the tenant did not pay the rent owed in full within the 5 days granted under section 46 (4) of the *Act* and did not apply to dispute the Notice within that 5-day period.

Based on the foregoing, I find that the tenant is conclusively presumed under section 46(5) of the *Act* to have accepted that the tenancy ended on the effective date of the Notice, February 17, 2015.

Therefore, I find that the landlord is entitled to an Order of Possession and a monetary Order of \$920.00 for unpaid rent owing for February 2015, as of February 18, 2015.

Conclusion

I grant an Order of Possession to the landlord effective **two days after service of this**Order on the tenant. Should the tenant(s) fail to comply with this Order, this Order may be filed and enforced as an Order of the Supreme Court of British Columbia.

Pursuant to section 67 of the *Act*, I find that the landlord is entitled to a monetary Order in the amount of \$920.00 for rent owed for February 2015, as of February 18, 2015. The landlord is provided with these Orders in the above terms and the tenant must be served with **this Order** as soon as possible. Should the tenant fail to comply with these Orders, these Orders may be filed in the Small Claims Division of the Provincial Court and enforced as Orders of that Court.
