DECISION

<u>Dispute Codes</u> OPR, MNR

<u>Introduction</u>

This matter proceeded by way of an *ex parte* Direct Request Proceeding, pursuant to section 55(4) of the *Residential Tenancy Act* (the "*Act*"), and dealt with an Application for Dispute Resolution by the landlord for an Order of Possession based on unpaid rent and a monetary Order.

The landlord submitted a signed Proof of Service of the Notice of Direct Request Proceeding which declares that on May 21, 2015, the landlord personally served Tenant J.S. the Notice of Direct Request Proceeding. The landlord had Tenant J.S. and a witness sign the Proof of Service of the Notice of Direct Request Proceeding to confirm personal service. Based on the written submission of the landlord and in accordance with section 89, I find that the tenant has been duly served with the Direct Request Proceeding documents on May 21, 2015, the day it was personally served to them.

The landlord submitted a second signed Proof of Service of the Notice of Direct Request Proceeding which declares that on May 21, 2015, the landlord sent Tenant M.S. the Notice of Direct Request Proceeding by registered mail to the rental unit. The landlord provided a copy of the Canada Post Customer Receipt containing the Tracking Number to confirm this mailing. Based on the written submissions of the landlord and in accordance with sections 89 and 90 of the *Act*, I find that Tenant M.S. has been deemed served with the Direct Request Proceeding documents on May 26, 2015, the fifth day after their registered mailing.

Issue(s) to be Decided

Is the landlord entitled to an Order of Possession for unpaid rent pursuant to sections 46 and 55 of the *Act*?

Is the landlord entitled to monetary compensation for unpaid rent pursuant to section 67 of the *Act*?

Background and Evidence

The landlord submitted the following evidentiary material:

- Two copies of the Proof of Service of the Notices of Direct Request Proceeding served to the tenants;
- A copy of a residential tenancy agreement which was signed by the landlord and the tenants on June 26, 2012, indicating a monthly rent of \$970.00, due on the first day of the month for a tenancy commencing on July 01, 2012;
- A second copy of a residential tenancy agreement which was signed by the landlord and the tenants in November of 2012, indicating a monthly rent of \$970.00, due on the first day of the month for a tenancy commencing on December 01, 2012;
- Two copies of Notice of Rent Increase forms showing the rent being increased from \$970.00 to the current monthly rent amount of \$1,010.00;
- A Tenant Ledger Card showing the rent owing and paid during this tenancy. The Tenant Ledger Card noted that \$50.00 of the \$1,240.00 identified as owing in the 10 Day Notice was paid on May 07, 2015; and
- A copy of a 10 Day Notice to End Tenancy for Unpaid Rent (the 10 Day Notice) dated May 04, 2015, and posted to the tenants' door on May 04, 2015, with a stated effective vacancy date of May 14, 2015, for \$1,240.00 in unpaid rent.

Witnessed documentary evidence filed by the landlord indicates that the 10 Day Notice was posted to the tenants' door at 11:35 a.m. on May 04, 2015. The 10 Day Notice states that the tenants had five days from the date of service to pay the rent in full or apply for Dispute Resolution or the tenancy would end.

<u>Analysis</u>

I have reviewed all documentary evidence and in accordance with sections 88 and 90 of the *Act*, I find that the tenants were deemed served with the 10 Day Notice on May 07, 2015, three days after its posting.

I find that the tenants were obligated to pay the monthly rent in the amount of \$1010.00 as per the tenancy agreement and the Notice of Rent Increase forms.

I accept the evidence before me that the tenants have failed to pay the rent owed in full within the 5 days granted under section 46 (4) of the *Act* and did not dispute the 10 Day Notice within that 5 day period

Based on the foregoing, I find that the tenants are conclusively presumed under section 46(5) of the *Act* to have accepted that the tenancy ended on the corrected effective date of the 10 Day Notice, May 17, 2015.

Therefore, I find that the landlord is entitled to an Order of Possession and a monetary Order in the amount of \$1,190.00, the amount claimed by the landlord, for unpaid rent owing for April 2015 and May 2015 as of May 20, 2015.

Conclusion

I grant an Order of Possession to the landlord effective **two days after service of this Order** on the tenant. Should the tenant(s) fail to comply with this Order, this Order may be filed and enforced as an Order of the Supreme Court of British Columbia.

Pursuant to section 67 of the *Act*, I find that the landlord is entitled to a monetary Order in the amount of \$1,190.00 for rent owed for April 2015 and May 2015. The landlord is provided with this Order in the above terms and the tenants must be served with **this Order** as soon as possible. Should the tenants fail to comply with this Order, this Order may be filed in the Small Claims Division of the Provincial Court and enforced as an Order of that Court.

This decision is made on authority delegated to me by the Director of the Residential Tenancy Branch under Section 9.1(1) of the *Residential Tenancy Act*.
