## **DECISION**

### **Introduction and Analysis**

This Hearing was scheduled to hear the Landlord's Application for Dispute Resolution seeking a monetary award for unpaid rent and damages; compensation for damage or loss under the Act, regulation or tenancy agreement; to apply the security deposit towards satisfaction of its monetary award; and to recover the cost of the filing fee from the Tenants.

This application was scheduled to be heard via teleconference on September 23, 2015, at 1:30 p.m. By 1:45 p.m., neither party had signed into the teleconference.

The Residential Tenancy Branch Rules of Procedure provide that the Hearing must commence at the scheduled time unless otherwise decided by the arbitrator. The arbitrator may conduct the hearing in the absence of a party and may make a decision or dismiss the application, with or without leave to re-apply.

As neither party attended the conference, I dismiss the Landlord's application with leave to re-apply. This does not extend any existing time limits that may apply.
