## **DECISION**

## <u>Introduction</u>

This telephone conference call hearing was convened as the result of the tenant's application for dispute resolution under the Residential Tenancy Act (the "Act"). The tenant applied for a monetary order for a return of her security deposit and pet damage deposit, doubled, and for recovery of the filing fee paid for this application.

The hearing began at the scheduled time and the telephone system remained open and was monitored for 14 minutes. During this time, the applicant/tenant did not dial into the telephone conference call hearing; however the landlord and her representative were present and ready to proceed with the hearing.

## Analysis and Conclusion

In the absence of the tenant to present her claim, pursuant to section 10.1 of the Dispute Resolution Rules of Procedure (Rules), and in light of the attendance by the respondent, I dismiss the tenant's application, without leave to reapply.
