A matter regarding WIDSTEN PROPERTY MANAGEMENT INC. and [tenant name suppressed to protect privacy]

DECISION

Dispute Codes OPR, MNR

Introduction

This matter proceeded by way of an *ex parte* Direct Request Proceeding, pursuant to section 55(4) of the *Residential Tenancy Act* (the "*Act*"), and dealt with an Application for Dispute Resolution by the landlord for an Order of Possession based on unpaid rent and a Monetary Order.

The landlord submitted a signed Proof of Service of the Notice of Direct Request Proceeding which declares that on March 3, 2017, the landlord sent the tenant the Notice of Direct Request Proceeding by registered mail to the rental unit. The landlord provided a copy of the Canada Post Customer Receipt containing the Tracking Number to confirm this mailing. Based on the written submissions of the landlord and in accordance with sections 89 and 90 of the *Act*, I find that the tenant has been deemed served with the Direct Request Proceeding documents on March 8, 2017, the fifth day after their registered mailing.

Issue(s) to be Decided

Is the landlord entitled to an Order of Possession for unpaid rent pursuant to sections 46 and 55 of the *Act*?

Is the landlord entitled to monetary compensation for unpaid rent pursuant to section 67 of the *Act*?

Background and Evidence

The landlord submitted the following evidentiary material:

• A copy of the Proof of Service of the Notice of Direct Request Proceeding served to the tenant;

- A copy of a residential tenancy agreement which was signed by the landlord and the tenant on June 13, 2015, indicating a monthly rent of \$425.00, due on the first day of the month for a tenancy commencing on June 1, 2015;
- A copy of a Notice of Rent Increase form, dated November 3, 2016, showing the rent being increased from \$425.00 to the current monthly rent amount of \$440.00 as of February 1, 2017;
- A Monetary Order Worksheet showing the rent owing and paid during the relevant portion of this tenancy; and
- A copy of a 10 Day Notice to End Tenancy for Unpaid Rent (the 10 Day Notice) dated February 7, 2017, and posted to the tenant's door on February 11, 2017, with a stated effective vacancy date of February 17, 2017, for \$440.00 in unpaid rent.

Witnessed documentary evidence filed by the landlord indicates that the 10 Day Notice was posted to the tenant's door at 12:06 pm on February 11, 2017. The 10 Day Notice states that the tenant had five days from the date of service to pay the rent in full or apply for Dispute Resolution or the tenancy would end.

<u>Analysis</u>

I have reviewed all documentary evidence and in accordance with sections 88 and 90 of the *Act,* I find that the tenant was deemed served with the 10 Day Notice on February 14, 2017, three days after its posting.

Part 3, section 41 of the *Act* establishes that "a landlord must not increase rent except in accordance with this Part"

Part 3, section 42 (2) of the *Act* establishes that the landlord "must give a tenant notice of a rent increase at least 3 months before the effective date of the increase", and section 42 (3) of the *Act* states that "A notice of a rent increase must be in the approved form."

I find that the Notice of Rent Increase form provided by the landlord did not allow for the full 3 months in accordance with Part 3 of the *Act*. For this reason, the monetary portion of the landlord's application is dismissed with leave to reapply.

However, I accept the evidence before me that the tenant has failed to pay the rent owed in full within the 5 days granted under section 46(4) of the *Act* and did not dispute the 10 Day Notice within that 5 day period.

Based on the foregoing, I find that the tenant is conclusively presumed under section 46(5) of the *Act* to have accepted that the tenancy ended on the corrected effective date of the 10 Day Notice, February 24, 2017.

Therefore, I find that the landlord is entitled to an Order of Possession for unpaid rent owing for February 2017 as of March 2, 2017.

Conclusion

I grant an Order of Possession to the landlord effective **two days after service of this Order** on the tenant. Should the tenant fail to comply with this Order, this Order may be filed and enforced as an Order of the Supreme Court of British Columbia.

I dismiss the landlord's application for a Monetary Order with leave to reapply.
