## **DECISION**

<u>Dispute Codes</u> OPR, MNR

### <u>Introduction</u>

This matter proceeded by way of an *ex parte* Direct Request Proceeding, pursuant to section 55(4) of the *Residential Tenancy Act* (the "*Act*"), and dealt with an Application for Dispute Resolution by the landlord for an Order of Possession based on unpaid rent and a Monetary Order.

The landlord submitted a signed Proof of Service of the Notice of Direct Request Proceeding which declares that on April 10, 2017, the landlord served the tenant the Notice of Direct Request Proceeding by handing the documents to Person V.S. The landlord had Person V.S. sign the Proof of Service of the Notice of Direct Request Proceeding to confirm this service.

### Issue(s) to be Decided

Is the landlord entitled to an Order of Possession for unpaid rent pursuant to sections 46 and 55 of the *Act*?

Is the landlord entitled to monetary compensation for unpaid rent pursuant to section 67 of the *Act*?

### Background and Evidence

The landlord submitted the following evidentiary material:

 A copy of the Proof of Service of the Notice of Direct Request Proceeding served to the tenant: Page: 2

• A copy of a residential tenancy agreement which was signed by the landlord and the tenant on December 15, 2016, indicating a monthly rent of \$2,545.00, due on the first day of the month for a tenancy commencing on January 1, 2017;

- A Monetary Order Worksheet showing the rent owing and paid during the relevant portion of this tenancy; and
- A copy of a 10 Day Notice to End Tenancy for Unpaid Rent (the 10 Day Notice) dated April 3, 2017, with a stated effective vacancy date of April 13, 2017, for \$2,545.00 in unpaid rent.

Documentary evidence filed by the landlord indicates that the 10 Day Notice was personally served to Person V.S. at 12:20 pm on April 3, 2017. The 10 Day Notice states that the tenant had five days from the date of service to pay the rent in full or apply for Dispute Resolution or the tenancy would end.

#### Analysis

In an *ex parte* Direct Request Proceeding, the onus is on the landlord to ensure that all submitted evidentiary material is in accordance with the prescribed criteria and that such evidentiary material does not lend itself to ambiguity or give rise to issues that may need further clarification beyond the purview of a Direct Request Proceeding. If the landlord cannot establish that all documents meet the standard necessary to proceed via the Direct Request Proceeding, the application may be found to have deficiencies that necessitate a participatory hearing, or, in the alternative, the application may be dismissed.

In this type of matter, the landlord must prove they served the tenant with the Notice of Direct Request proceeding with all the required inclusions as indicated on the Notice as per Section 89 of the *Act*.

Section 89(1) of the *Act* does <u>not</u> allow for the Notice of Direct Request Proceeding to be left with an adult who apparently resides with the tenant.

Section 89(2) of the *Act* does allow for the Notice of Direct Request Proceeding to be left with an adult who apparently resides with the tenant, only when considering the issuance of an Order of Possession for the landlord.

The Proof of Service of the Notice of Direct Request Proceeding that was submitted by the landlord indicates service to Person V.S., but there is no indication or

documentation in the evidence that the person who received the documents was an

adult.

As I am unable to confirm service of the Notice of Direct Request Proceeding to the tenant, the landlord's application to end this tenancy and obtain an Order of Possession

is dismissed with leave to reapply.

For the same reasons, the landlord's application for a Monetary Order is dismissed with

leave to reapply.

Conclusion

I dismiss the landlord's application with leave to reapply.
