## **DECISION**

Pursuant to the *Residential Tenancy Act*, R.S.B.C. and amendments thereto I was designated to hear this matter under section 58. This hearing dealt with an application pursuant to the *Residential Tenancy Act* SBC 2002 ("the Act") in respect of the above-noted tenancy and was set for 10:30 a.m. on September 5, 2017. ### **Rule 10.1 of the Rules of Procedure provides as follows:**
