DECISION

Dispute Codes OPR-DR

Introduction

This matter proceeded by way of an *ex parte* Direct Request Proceeding, pursuant to section 55(4) of the *Residential Tenancy Act* (the "*Act*"), and dealt with an Application for Dispute Resolution by the landlord for an Order of Possession based on unpaid rent.

The landlord submitted a signed Proof of Service of the Notice of Direct Request Proceeding which declares that on November 27, 2017, the landlord sent the tenant the Notice of Direct Request Proceeding by registered mail to the rental unit. The landlord provided a copy of the Canada Post Customer Receipt containing the Tracking Number to confirm this mailing. Based on the written submission of the landlord and in accordance with sections 89 and 90 of the *Act*, I find that the tenant has been deemed served with the Direct Request Proceeding documents on December 02, 2017, the fifth day after their registered mailing.

Issue(s) to be Decided

Is the landlord entitled to an Order of Possession for unpaid rent pursuant to sections 46 and 55 of the *Act*?

Background and Evidence

The landlord submitted the following evidentiary material:

- A copy of a residential tenancy agreement which was signed by the landlord on November 09, 2015 and the tenant on November 08, 2015, indicating a monthly rent of \$955.00, due on the first day of each month for a tenancy commencing on December 01, 2015;
- A copy of document entitled "One Tenant Vacating and/or Transfer of Security Deposit" dated August 28, 2017 signed by Person N.A. and the tenant;
- A copy of a 10 Day Notice to End Tenancy for Unpaid Rent dated October 02, 2017 for \$982.00 in unpaid rent (the 10 Day Notice). The 10 Day Notice provides that the tenant

had five days from the date of service to pay the rent in full or apply for Dispute Resolution or the tenancy would end on the stated effective vacancy date of October 15,

2017;

A copy of a Proof of Service Notice to End Tenancy form which indicates that the 10 Day

Notice was posted to the tenant's door at 9:00 a.m. on October 02, 2017; and

A Monetary Order Worksheet showing the rent owing and paid during the relevant

portion of this tenancy.

Analysis

I have reviewed all documentary evidence and in accordance with sections 88 and 90 of the Act, I find that the tenant was deemed served with the 10 Day Notice on October 05, 2017,

three days after its posting.

I accept the evidence before me that the tenant has failed to pay the rent owed in full within the five days granted under section 46(4) of the Act and did not dispute the 10 Day Notice within

that five day period.

Based on the foregoing, I find that the tenant is conclusively presumed under section 46(5) of

the Act to have accepted that the tenancy ended on the effective date of the 10 Day Notice,

October 15, 2017.

Therefore, I find that the landlord is entitled to an Order of Possession for unpaid rent owing for

October 2017 as of November 20, 2017.

Conclusion

I grant an Order of Possession to the landlord effective two days after service of this Order on the tenant. Should the tenant fail to comply with this Order, this Order may be filed and

enforced as an Order of the Supreme Court of British Columbia.
