## DECISION

Dispute Codes OPRU-DR

#### Introduction

This matter proceeded by way of an *ex parte* Direct Request Proceeding, pursuant to section 55(4) of the *Residential Tenancy Act* (the *Act*), and dealt with an Application for Dispute Resolution by the landlord for an Order of Possession based on unpaid rent.

The landlord submitted two signed Proofs of Service of the Notices of Direct Request Proceeding which declare that on January 20, 2018, the landlord sent each of the tenants the Notice of Direct Request Proceeding by registered mail to the rental unit. The landlord provided a copy of the Canada Post Customer Receipts containing the Tracking Numbers to confirm these mailings. Based on the written submissions of the landlord and in accordance with sections 89 and 90 of the *Act*, I find that the tenants are deemed to have been served with the Direct Request Proceeding documents on January 25, 2018, the fifth day after their registered mailing.

#### Issue(s) to be Decided

Is the landlord entitled to an Order of Possession for unpaid rent pursuant to sections 46 and 55 of the *Act*?

### Background and Evidence

The landlord submitted the following evidentiary material:

- A copy of a residential tenancy agreement which was signed by the landlord and the tenants on November 22, 2014, indicating a monthly rent of \$1,495.00, due on the first day of each month for a tenancy commencing on December 1, 2014;
- Two copies of utility bills from BC Hydro for the rental unit dated September 18, 2017 for \$119.00 and October 18, 2017 for \$119.00;
- Two copies of utility bills from Fortis BC for the rental unit dated September 18, 2017 for \$109.33 and October 19, 2017 for \$82.00;

- Three copies of invoices billed to the tenants dated November 1, 2017 for \$1,710.80, December 1, 2017 for \$1,710.01, and January 1, 2018 for \$1,747.96;
- A copy of a 10 Day Notice to End Tenancy for Unpaid Rent dated January 3, 2018 for \$4,846.07 in unpaid rent and \$209.37 in unpaid utilities (the 10 Day Notice). The 10 Day Notice provides that the tenants had five days from the date of service to pay the rent in full or apply for Dispute Resolution or the tenancy would end on the stated effective vacancy date of January 17, 2018;
- A copy of a witnessed Proof of Service Notice to End Tenancy form which indicates that the 10 Day Notice was posted to the tenants' door at 6:30 pm on January 3, 2018; and
- A Direct Request Worksheet showing the rent owing and paid during the relevant portion of this tenancy.

#### <u>Analysis</u>

I have reviewed all documentary evidence and in accordance with sections 88 and 90 of the *Act*, I find that the tenants were deemed served with the 10 Day Notice on January 6, 2018, three days after its posting.

I accept the evidence before me that the tenants have failed to pay the rent owed in full within the five days granted under section 46(4) of the *Act* and did not dispute the 10 Day Notice within that five day period.

Based on the foregoing, I find that the tenants are conclusively presumed under section 46(5) of the *Act* to have accepted that the tenancy ended on the effective date of the 10 Day Notice, January 17, 2018.

Therefore, I find that the landlord is entitled to an Order of Possession for unpaid rent owing as of January 18, 2018.

#### **Conclusion**

I grant an Order of Possession to the landlord effective **two days after service of this Order** on the tenant(s). Should the tenant(s) fail to comply with this Order, this Order may be filed and enforced as an Order of the Supreme Court of British Columbia.
