## **DECISION**

### Introduction

This matter proceeded by way of an *ex parte* Direct Request Proceeding pursuant to section 55(4) of the *Residential Tenancy Act* (the “*Act*”), and dealt with an Application for Dispute Resolution by the landlord for an Order of Possession based on unpaid rent and a Monetary Order.

The landlord submitted a signed Proof of Service of the Notice of Direct Request Proceeding which declares that on January 25, 2018, the agent for the landlord sent the tenant the Notice of Direct Request Proceeding by registered mail to the rental unit. The landlord provided a copy of the Canada Post Customer Receipt containing the Tracking Number to confirm this mailing. Based on the written submission of the landlord and in accordance with sections 89 and 90 of the *Act*, I find that the tenant is deemed to have been served with the Direct Request Proceeding documents on January 30, 2018, the fifth day after their registered mailing.

### Issue(s) to be Decided

Is the landlord entitled to an Order of Possession for unpaid rent pursuant to sections 46 and 55 of the *Act*?

Is the landlord entitled to monetary compensation for unpaid rent pursuant to section 67 of the *Act*?

Is the landlord entitled to recover the filing fee for this application pursuant to section 72 of the *Act*?

### Background and Evidence

The landlord submitted the following evidentiary material:

- A copy of a Property Management Agreement made between the landlord and his agent, N.&A.R.L., made as of February 14, 2012;
- A copy of a residential tenancy agreement made on April 22, 2013 between the agent for the landlord and the tenant indicating a monthly rent of \$5,100.00, due on the first day of each month for a tenancy commencing on July 01, 2013;
- A copy of five addendums to the initial tenancy agreement made on April 22, 2013 signed by the agent for the landlord and tenant. The most recent addendum was signed by the agent for the landlord and tenant on September 08, 2017, which sets out the term of the lease starts on November 01, 2017, with a monthly rent of \$6,325.00 (the Recent Addendum);
- A copy of a 10 Day Notice to End Tenancy for Unpaid Rent dated January 04, 2018 for \$6,325.00 in unpaid rent (the 10 Day Notice). The 10 Day Notice provides that the tenant had five days from the date of service to pay the rent in full or apply for Dispute Resolution or the tenancy would end on the stated effective vacancy date of January 19, 2018;
- A copy of a Proof of Service Notice to End Tenancy form which indicates that the 10 Day Notice was sent to the tenant by registered mail at 7:20 p.m. on January 04, 2018;
- A Direct Request Worksheet showing the rent owing and paid during the relevant portion of this tenancy; and
- A copy of a Letter of Employment Verification from the agent, N.&A.P.M., in relation to their employee N.C.;

### Analysis

I have reviewed all documentary evidence and in accordance with sections 88 and 90 of the *Act*, I find that the tenant was deemed served with the 10 Day Notice on January 09, 2018, five days after its mailing.

I find that the tenant was obligated to pay the monthly rent in the amount of \$6,325.00, as per the initial residential tenancy agreement and the Recent Addendum;

I accept the evidence before me that the tenant has failed to pay the rent owed in full within the five days granted under section 46(4) of the *Act* and did not dispute the 10 Day Notice within that five day period.

Based on the foregoing, I find that the tenant is conclusively presumed under section 46(5) of the *Act* to have accepted that the tenancy ended on the effective date of the 10 Day Notice, January 19, 2018.

Therefore, I find that the landlord is entitled to an Order of Possession and a Monetary Order in the amount of \$6,325.00, the amount claimed by the landlord, for unpaid rent owing for January 2018 as of January 24, 2018.

As the landlord was successful in this application, I find that the landlord is entitled to recover the \$100.00 filing fee paid for this application.

### Conclusion

I grant an Order of Possession to the landlord effective **two days after service of this Order** on the tenant. Should the tenant fail to comply with this Order, this Order may be filed and enforced as an Order of the Supreme Court of British Columbia.

Pursuant to sections 67 and 72 of the *Act*, I grant the landlord a Monetary Order in the amount of \$6,425.00 for rent owed for January 2018 and for the recovery of the filing fee for this application. The landlord is provided with this Order in the above terms and the tenant must be served with **this Order** as soon as possible. Should the tenant fail to comply with this Order, this Order may be filed in the Small Claims Division of the Provincial Court and enforced as an Order of that Court.

This decision is made on authority delegated to me by the Director of the Residential Tenancy Branch under section 9.1(1) of the *Act*.
