Analysis

This hearing dealt with tenant's application pursuant to section 58 of the *Residential Tenancy Act* (the "Act").

While the respondent landlord, J.Y. attended the hearing by way of conference call, the applicant tenant did not, although I waited until 1:40 P.M. in order to enable the tenant to connect with this teleconference hearing scheduled for 1:30 P.M.

Rule 7.1 of the Rules of Procedure provides as follows:

7.1 Commencement of the hearing. The hearing must commence at the scheduled time unless otherwise decided by the arbitrator. The arbitrator may conduct the hearing in the absence of a party and may make a decision or dismiss the application, with or without leave to re-apply.

Conclusion

In the absence of the applicant's participation in this hearing, I order the application dismissed in its entirety without liberty to reapply.
