Introduction

This hearing was convened by way of conference call in response to an Application for Dispute Resolution filed by the Landlord on April 16, 2018 (the "Application"). The Landlord applied for an Order of Possession based on a 10 Day Notice to End Tenancy for Unpaid Rent or Utilities. The Landlord also sought a Monetary Order for unpaid rent and to recover the filing fee.

Neither party attended at the appointed time set for the hearing on May 22, 2018. I waited 12 minutes, until 1:42 p.m., to enable the parties to participate in this hearing scheduled for 1:30 p.m. I confirmed from the teleconference system that I was the only person who had called into this teleconference. I confirmed that the correct call-in numbers and participant code had been provided in the Notice of Hearing.

Given that neither party attended the hearing, I dismiss the Application with leave to re-apply. However, this does not extend any time limits set out in the *Residential Tenancy Act* (the "Act").

Conclusion

The Application is dismissed with leave to re-apply. This does not extend any time limits set out in the *Act*.
