DECISION

Introduction

This is an Application for Dispute Resolution (the "Application") brought by the Tenant requesting \$3,680.00 for wrongful eviction. The Tenant also request an order for payment of the filing fee of \$100.00.

Neither party attended at the appointed time set for the hearing, although I waited 10 minutes to enable them to participate in this hearing scheduled for 1:30 pm. I confirmed that the correct call-in numbers and participant codes had been provided in the Notice of Hearing. I also confirmed from the teleconference system that I was the only person who had called into this teleconference.

Issues to be Decided

Is the Tenant entitled to a monetary order for damage or compensation pursuant to section 67 of the Residential Tenancy Act ("Act")?

Is the Tenant entitled to an order for payment of the filing fee, pursuant to section 72 of the Act?

Analysis and Conclusion

Rule 7.3 of the Residential Tenancy Branch Rules of Procedure states if a party or their agent fails to attend a hearing, the Arbitrator may conduct the dispute resolution hearing in the absence of that party, or dismiss the Application, with or without leave to re-apply.

As neither party called into the conference call by 1:40 pm., I find the Tenant has not presented the merits of this Application which is hereby **dismissed with leave to**

reapply. However, this does not extend any applicable time limits under the *Residential Tenancy Act* and I have made no findings of fact or law with respect to the merits of this Application.

Conclusion

The Application is dismissed with leave to reapply.
