DECISION

Dispute Codes OPRM-DR, FFL

Introduction

This matter proceeded by way of an *ex parte* Direct Request Proceeding, pursuant to section 55(4) of the *Residential Tenancy Act* (the “*Act*”), and dealt with an Application for Dispute Resolution by the landlord for an Order of Possession based on unpaid rent and a Monetary Order.

The landlord submitted a signed Proof of Service of the Notice of Direct Request Proceeding form which declares that on August 08, 2018, the landlord’s agent served the tenant “WB” with the Notice of Direct Request Proceeding via registered mail. The landlord provided a copy of the Canada Post Customer Receipt containing the Tracking Number to confirm this mailing. Section 90 of the *Act* determines that a document served in this manner is deemed to have been received five days after service.

Based on the written submissions of the landlord, and in accordance with sections 89 and 90 of the *Act*, I find that the tenant “WB” has been deemed served with the Direct Request Proceeding documents on August 13, 2018, the fifth day after their registered mailing.

Although an individual identified as “HC” is included on the application for dispute resolution as an applicant landlord, “HC” is not listed as a landlord on the tenancy agreement. As neither the name nor signature for “HC” appears on the tenancy agreement to demonstrate that “HC” entered into a tenancy agreement with the tenant, I will consider the application with “MC” being the sole landlord, and amend the application to exclude “HC” as a party to this dispute.

Although a second individual, identified as “SG”, is listed as a respondent tenant on the application for dispute resolution, neither the name nor signature for “SG” appears on the tenancy agreement to demonstrate that “SG” entered into a tenancy with the applicant landlord and endorsed the terms of the tenancy agreement as a tenant. Therefore, I will consider the landlord’s application against the tenant “WB” only.

Issue(s) to be Decided

Is the landlord entitled to an Order of Possession for unpaid rent pursuant to sections 46 and 55 of the *Act*?

Is the landlord entitled to monetary compensation for unpaid rent pursuant to section 67 of the *Act*?

Is the landlord entitled to recover the filing fee for this application pursuant to section 72 of the *Act*?

Background and Evidence

The landlord submitted the following evidentiary material:

- A copy of a residential tenancy agreement which was signed by the landlord and the tenant, indicating a monthly rent of \$2,200.00, due on the first day of each month for a tenancy commencing on October 01, 2017;
- A Direct Request Worksheet showing the rent owing and paid during the portion of this tenancy in question, on which the landlord establishes a monetary claim in the amount of \$8,875.00 for outstanding rent due by July 01, 2018, comprised of the balance of unpaid rent owed for the months comprising the period of March 2018 to July 2018;
- A copy of a 10 Day Notice to End Tenancy for Unpaid Rent (the Notice) dated July 10, 2018, which the landlord states was served to the tenant on July 10, 2018, for \$8,875.00 in unpaid rent due on July 01, 2018, with a stated effective vacancy date of July 20, 2018; and
- A copy of the Proof of Service of the Notice form asserting that the landlord's agent served the Notice to the tenant "WB" by way of personal service via hand-delivery on July 10, 2018. The Proof of Service form establishes that the service of the Notice was witnessed and a name and signature for the witness are included on the form.

The Notice restates section 46(4) of the *Act* which provides that the tenant had five days to pay the rent in full or apply for Dispute Resolution or the tenancy would end on the effective date of the Notice. The tenant did not apply to dispute the Notice within five days from the date of service and the landlord alleged that the tenant did not pay the rental arrears.

Analysis

I have reviewed all documentary evidence and find that in accordance with section 88 of the *Act* the tenant was duly served with the Notice on July 10, 2018.

I find that the tenant was obligated to pay monthly rent in the amount of \$2,200.00, as established in the tenancy agreement. I accept the evidence before me that the tenant has failed to pay rental arrears in the amount of \$8,875.00, comprised of the balance of unpaid rent owed by July 01, 2018 for the months comprising the period of March 2018 to July 2018.

I accept the landlord's undisputed evidence and find that the tenant did not pay the rent owed in full within the five days granted under section 46 (4) of the *Act* and did not apply to dispute the Notice within that five-day period.

Based on the foregoing, I find that the tenant is conclusively presumed under section 46(5) of the *Act* to have accepted that the tenancy ended on the effective date of the Notice, July 20, 2018.

Therefore, I find that the landlord is entitled to an Order of Possession and a monetary Order of \$8,875.00 for unpaid rent owed by July 01, 2018, as claimed on the landlord's Application for Dispute Resolution by Direct Request.

As the landlord was successful in this application, I find that the landlord is entitled to recover the \$100.00 filing fee paid for this application.

Conclusion

I grant an Order of Possession to the landlord effective **two days after service of this Order** on the tenant. Should the tenant(s) fail to comply with this Order, this Order may be filed and enforced as an Order of the Supreme Court of British Columbia.

Pursuant to sections 67 and 72 of the *Act*, I find that the landlord is entitled to a monetary Order in the amount of \$8,975.00 for unpaid rent, and for the recovery of the filing fee for this application. The landlord is provided with these Orders in the above terms and the tenant must be served with **this Order** as soon as possible. Should the tenant fail to comply with these Orders, these Orders may be filed in the Small Claims Division of the Provincial Court and enforced as Orders of that Court.
