DECISION

Introduction

This is an Application for Dispute Resolution (the "Application") brought by the Landlord requesting a monetary order for compensation and/or damages. The Landlord also requests an order for payment of the filing fee.

Neither party attended at the appointed time set for the hearing, although I waited 10 minutes to enable them to participate in this hearing scheduled for 1:30 p.m. I confirmed that the correct call-in numbers and participant codes had been provided in the Notice of Hearing. I also confirmed from the teleconference system that I was the only person who had called into this teleconference.

Issues to be Decided

Is the Landlord entitled to a monetary order for compensation and/or damages, pursuant to section 67 of the Residential Tenancy Act ("Act")?

Is the Landlord entitled to payment of the \$100.00 filing fee, pursuant to section 72 of the Act?

Analysis and Conclusion

Rule 7.3 of the Residential Tenancy Branch Rules of Procedure states if a party or their agent fails to attend a hearing, the Arbitrator may conduct the dispute resolution hearing in the absence of that party, or dismiss the Application, with or without leave to re-apply. As neither party called into the conference call by 1:40 p.m., I find the Landlord has not presented the merits of this Application which is hereby **dismissed with leave to reapply**. However, this does not extend any applicable time limits under the *Residential*

Tenancy Act and I have made no findings of fact or law with respect to the merits of this Application.
