Introduction

This hearing was scheduled for 11:00 p.m. on this date, via teleconference call, to deal with the tenant's application to cancel a 1 Month Notice to End Tenancy for Cause and more time to make the application. Neither party attended the hearing, although I waited at least 10 minutes to enable them to participate in this hearing. I confirmed that the correct call-in numbers and participant codes had been provided in the Notice of Hearing. I also confirmed from the teleconference system that I was the only person who had called into this teleconference. As neither the applicant nor the respondent attended the hearing, I dismiss the application with leave to reapply. This does not extend any applicable time limits under the Act.

Since there was no appearance by either party, I am unable to verify service of hearing documents and I have not considered any of the evidence uploaded to the Residential Tenancy Branch. Accordingly, I am unable to verify whether the 1 Month Notice complies with section 52 of the Act and I do not issue an Order of Possession to the landlord with this decision.
