DECISION

<u>Introduction</u>

This matter proceeded by way of an *ex parte* Direct Request Proceeding, pursuant to section 55(4) of the *Residential Tenancy Act* (the *Act*), and dealt with an Application for Dispute Resolution by the landlord for an Order of Possession based on unpaid rent.

The landlord submitted two signed Proofs of Service of the Notices of Direct Request Proceeding which declare that on October 25, 2018, the landlord personally served each of the tenants the Notice of Direct Request Proceeding. The landlord had the tenants and a witness sign the Proofs of Service of the Notices of Direct Request Proceeding to confirm personal service. Based on the written submissions of the landlord and in accordance with section 89 of the *Act*, I find that the tenants have been duly served with the Direct Request Proceeding documents on October 25, 2018.

Issue(s) to be Decided

Is the landlord entitled to an Order of Possession for unpaid rent pursuant to sections 46 and 55 of the *Act*?

Background and Evidence

The landlord submitted the following evidentiary material:

- A copy of a residential tenancy agreement which was signed by the landlord and Tenant T.R. on September 1, 2017, indicating a monthly rent of \$1,850.00, due on the first day of each month for a tenancy commencing on January 1, 2016;
- A copy of a Notice of Rent Increase form showing the rent being increased from \$1,850.00 to the current monthly rent amount of \$1,924.00;

- A copy of a 10 Day Notice to End Tenancy for Unpaid Rent (the 10 Day Notice)
 dated October 6, 2018, for \$1,924.00 in unpaid rent. The 10 Day Notice provides
 that the tenants had five days from the date of service to pay the rent in full or
 apply for Dispute Resolution or the tenancy would end on the stated effective
 vacancy date of October 16, 2018;
- A copy of a Proof of Service Notice to End Tenancy form which was signed by Tenant T.R. and indicates that the 10 Day Notice was personally served to the tenants at 8:00 pm on October 6, 2018; and
- A Direct Request Worksheet showing the rent owing and paid during the relevant portion of this tenancy.

<u>Analysis</u>

I have reviewed all documentary evidence and in accordance with section 88 of the *Act*, I find that the tenants were duly served with the 10 Day Notice on October 6, 2018.

Paragraph 12 (1) (b) of the Residential Tenancy Regulation establishes that a tenancy agreement is required to be "signed and dated by both the landlord and the tenant."

I find that Tenant D.H. has not signed the tenancy agreement, which is a requirement of the direct request process. For this reason, I will only proceed with the portion of the landlord's application naming Tenant T.R. as a respondent.

I find that Tenant T.R. was obligated to pay the monthly rent in the amount of \$1,924.00, as per the tenancy agreement and the Notice of Rent Increase.

I accept the evidence before me that Tenant T.R. has failed to pay the rent owed in full within the five days granted under section 46(4) of the *Act* and did not dispute the 10 Day Notice within that five day period.

Based on the foregoing, I find that Tenant T.R. is conclusively presumed under section 46(5) of the *Act* to have accepted that the tenancy ended on the effective date of the 10 Day Notice, October 16, 2018.

Therefore, I find that the landlord is entitled to an Order of Possession for unpaid rent owing for October 2018 as of October 17, 2018.

Conclusion

I grant an Order of Possession to the landlord effective **two days after service of this Order** on Tenant T.R. Should Tenant T.R. **and any other occupant** fail to comply with this Order, this Order may be filed and enforced as an Order of the Supreme Court of British Columbia.

This decision is made on authority delegated to me by the Director of the Residential Tenancy Branch under Section 9.1(1) of the *Residential Tenancy Act*.
