## DECISION

#### Introduction

This hearing was convened by way of conference call in response to an Application for Dispute Resolution filed by the Tenants on October 9, 2018 (the "Application"). The Tenants disputed a 10 Day Notice to End Tenancy for Unpaid Rent or Utilities dated October 5, 2018.

Neither party attended at the appointed time set for the hearing on November 19, 2018. I waited until 11:11 a.m. to enable the parties to participate in this hearing scheduled for 11:00 a.m. I confirmed from the teleconference system that I was the only person who had called into this teleconference. I confirmed the correct call-in numbers and participant code had been provided in the Notice of Hearing.

Given neither party attended the hearing, I dismiss the Application with leave to re-apply. However, this does not extend any time limits set out in the *Residential Tenancy Act* (the "*Act*").

#### **Conclusion**

The Application is dismissed with leave to re-apply. This does not extend any time limits set out in the *Act*.
