DECISION

Introduction

This teleconference hearing was scheduled in response to an application by the Landlords under the *Residential Tenancy Act* (the "*Act*") for monetary compensation for unpaid rent, and for the recovery of the filing fee paid for the Application for Dispute Resolution.

Neither party called into the hearing during the approximately 10 minutes that the teleconference line was monitored.

Issues to be Decided

Are the Landlords entitled to monetary compensation for unpaid rent?

Should the Landlords be awarded the recovery of the filing fee paid for the Application for Dispute Resolution?

Background and Evidence

The teleconference hearing was scheduled for 1:30 pm on July 25, 2019. I called into the hearing at 1:30 pm and the phone line was monitored until 1:40 pm. The teleconference codes and call-in numbers were confirmed to be accurate on the Notice of Dispute Resolution Proceeding.

<u>Analysis</u>

Rule 7.1 of the *Residential Tenancy Branch Rules of Procedure* states that the hearing commences at the scheduled time, unless otherwise determined by the Arbitrator. Rule

7.3 of the *Rules of Procedure* states that in the absence of a party, the hearing may be conducted in their absence or the dispute dismissed, with or without leave to reapply.

Due to the absence of both parties, I find that this Application for Dispute Resolution has been abandoned.

Conclusion

I dismiss the Application for Dispute Resolution with leave to reapply. This decision does not extend any applicable time limits under the *Residential Tenancy Act.* No findings of fact or law were made with respect to the dispute.
