DECISION

Dispute Codes OPR-DR-PPL, FFL

Introduction

This matter proceeded by way of an *ex parte* Direct Request Proceeding, pursuant to section 55(4) of the *Residential Tenancy Act* (the *Act*), and dealt with an Application for Dispute Resolution by the landlord for an Order of Possession based on unpaid rent.

The landlord submitted two signed Proof of Service Notice of Direct Request Proceeding forms which declare that on September 25, 2020, the landlord sent each of the tenants the Notice of Direct Request Proceeding by registered mail to the rental unit.

The landlord provided a copy of a Canada Post Customer Receipt containing a Tracking Number to confirm this mailing was sent to Tenant L.J.G.M. Based on the written submissions of the landlord and in accordance with sections 89 and 90 of the *Act*, I find that Tenant L.J.G.M. is deemed to have been served with the Direct Request Proceeding documents on September 30, 2020, the fifth day after their registered mailing.

I find the landlord has not submitted a copy of a Canada Post Customer Receipt containing a Tracking Number to confirm the Notice of Direct Request Proceeding documents were sent to Tenant K.C. For this reason, I will only proceed with the portion of the landlord's application naming Tenant L.J.G.M. as a respondent.

Issue(s) to be Decided

Is the landlord entitled to an Order of Possession for unpaid rent pursuant to sections 46 and 55 of the *Act*?

Is the landlord entitled to recover the filing fee for this application pursuant to section 72 of the *Act*?

Background and Evidence

I have reviewed all written submissions and evidence before me; however, only the evidence and submissions relevant to the issues and findings in this matter are described in this decision.

The landlord submitted the following relevant evidentiary material:

- A copy of a residential tenancy agreement which was signed by the landlord and Tenant L.J.G.M. on March 13, 2020, indicating a monthly rent of \$3,400.00, due on the first day of each month for a tenancy commencing on March 13, 2020;
- A copy of a 10 Day Notice to End Tenancy for Unpaid Rent (the 10 Day Notice) dated September 5, 2020, for \$1,700.00 in unpaid rent. The 10 Day Notice provides that Tenant L.J.G.M. had five days from the date of service to pay the rent in full or apply for Dispute Resolution or the tenancy would end on the stated effective vacancy date of September 15, 2020;
- A copy of a Proof of Service Notice to End Tenancy form which indicates that the 10 Day Notice was sent to Tenant L.J.G.M. by registered mail at 9:07 am on September 8, 2020;
- A copy of a Canada Post Tracking Report containing the Tracking Number to confirm the 10 Day Notice was sent to Tenant L.J.G.M. on September 8, 2020; and
- A Direct Request Worksheet showing the rent owing and paid during the relevant portion of this tenancy.

Analysis

I have reviewed all documentary evidence and in accordance with sections 88 and 90 of the *Act*, I find that Tenant L.J.G.M. was deemed served with the 10 Day Notice on September 13, 2020, five days after its registered mailing.

I accept the evidence before me that Tenant L.J.G.M. has failed to pay the rent owed in full within the five days granted under section 46(4) of the *Act* and did not dispute the 10 Day Notice within that five-day period.

Based on the foregoing, I find that Tenant L.J.G.M. is conclusively presumed under sections 46(5) and 53(2) of the *Act* to have accepted that the tenancy ended on the corrected effective date of the 10 Day Notice, September 23, 2020.

Therefore, I find that the landlord is entitled to an Order of Possession for unpaid rent as of the date of this application, September 20, 2020.

As the landlord was partially successful in this application, I find that the landlord is entitled to recover the \$100.00 filing fee paid for this application.

Conclusion

I grant an Order of Possession to the landlord effective **two days after service of this Order** on Tenant L.J.G.M. Should Tenant L.J.G.M. **and any other occupant** fail to comply with this Order, this Order may be filed and enforced as an Order of the Supreme Court of British Columbia.

Pursuant to section 72 of the *Act*, I grant the landlord a Monetary Order in the amount of \$100.00 for the recovery of the filing fee for this application. The landlord is provided with this Order in the above terms and Tenant L.J.G.M. must be served with **this Order** as soon as possible. Should Tenant L.J.G.M. fail to comply with this Order, this Order may be filed in the Small Claims Division of the Provincial Court and enforced as an Order of that Court.

This decision is made on authority delegated to me by the Director of the Residential Tenancy Branch under Section 9.1(1) of the *Residential Tenancy Act*.
