DECISION

Dispute Codes OPR-DR, MNR-DR, FFL

Introduction

This matter proceeded by way of an ex parte Direct Request Proceeding pursuant to section 55(4) of the Residential Tenancy Act (the Act) and dealt with an Application for Dispute Resolution filed by the Landlords for an order of possession and a monetary order for unpaid rent and to recover the filing fee.

The Landlords submitted signed Proof of Service Notice of Direct Request Proceeding documents which declare that they served each of the Tenants with a Notice of Dispute Resolution Proceeding and supporting evidence in person on January 26, 2022. Receipt of these documents was acknowledged by the Tenants' signatures. I find these documents were served on and received by the Tenants on January 26, 2022, the day they were served in person.

Issues to be Decided

1. Are the Landlords entitled to an order of possession for unpaid rent pursuant to sections 46 and 55 of the Act?
2. Are the Landlords entitled to a monetary order for unpaid rent pursuant to sections 46 and 67 of the Act?
3. Are the Landlords entitled to recover the filing fee pursuant to section 72 of the Act?

Background and Evidence

I have reviewed all written submissions and evidence before me; however, only the evidence and submissions relevant to the issues and findings in this matter are described in this decision.

The Landlords submitted the following relevant evidentiary material:

- A copy of a residential tenancy agreement signed by the parties on March 31, 2021, indicating a monthly rent in the amount of \$1,500.00 due on the first day of each month, for a tenancy commencing on April 1, 2021;
- A copy of a 10 Day Notice to End Tenancy for Unpaid Rent or Utilities dated January 3, 2022, for \$1,500.00 in unpaid rent (the 10 Day Notice). The 10 Day Notice provides that the Tenants had five days from the date of service to pay the rent in full or apply for Dispute Resolution or the tenancy would end on the stated effective vacancy date of January 10, 2022;
- A copy of a signed Proof of Service Notice to End Tenancy document which indicates that the 10 Day Notice was served on the Tenants by attaching a copy to the door of the Tenants' residence on January 3, 2022, which service was witnessed by N.B.N.; and
- A copy of a Direct Request Worksheet showing the rent due and paid during the relevant period.

Analysis

I have reviewed all documentary evidence and I find that the Tenants were obligated to pay monthly rent in the amount of \$1,500.00.

In accordance with sections 88 and 90 of the Act, I find that the Tenants are deemed to have received the 10 Day Notice on January 6, 2022, three days after it was attached to the Tenants' door.

I find the 10 Day Notice complies with the form and content requirements of section 52 of the Act.

I accept the evidence before me that the Tenants failed to pay the rent owed in full and did not dispute the 10 Day Notice within five days after receipt of the 10 Day Notice in accordance with section 46(4) of the Act.

Based on the foregoing, I find that the Tenants are conclusively presumed under section 46(5) of the Act to have accepted that the tenancy ended on January 16, 2022, the corrected effective date of the 10 Day Notice.

Therefore, I find the Landlords are entitled to an order of possession which will be effective two days after it is served on the Tenants.

I also find the Landlords have demonstrated an entitlement to a monetary award in the amount of \$1,500.00 for unpaid rent to January 31, 2022. Claims under the Direct Request process are limited to what is indicated in the 10 Day Notice. The Landlords remains at liberty to reapply for a monetary order for any additional unpaid rent or other losses.

Having been successful, I also find the Landlords are entitled to recover the \$100.00 filing fee paid to make the application.

Conclusion

The Landlords are granted an order of possession which will be effective two days after it is served on the Tenants. The order of possession must be served on the Tenants. The order of possession may be filed in and enforced as an order of the Supreme Court of British Columbia.

The Landlords are granted a monetary order in the amount of \$1,600.00 for unpaid rent and in recovery of the filing fee. The monetary order must be served on the Tenants. The monetary order may be filed in and enforced as an order of the Provincial Court of British Columbia (Small Claims).

This decision is made on authority delegated to me by the Director of the Residential Tenancy Branch under Section 9.1(1) of the Residential Tenancy Act.
