## **DECISION**

**Dispute Codes**      **OPR-DR, MNR-DR, FFL**

### **Introduction**

This matter proceeded by way of an *ex parte* Direct Request Proceeding, pursuant to section 55(4) of the *Residential Tenancy Act* (the *Act*), and dealt with an Application for Dispute Resolution to obtain an Order of Possession based on unpaid rent, to obtain monetary compensation for unpaid rent, and to recover the filing fee paid for the application.

This decision is written based on the Application for Dispute Resolution, evidence, and submissions provided by the applicant on January 27, 2022.

The applicant submitted a copy of two witnessed Proof of Service Notice of Direct Request Proceeding forms which declare that on February 10, 2022, the applicant personally served each tenant the Notice of Dispute Resolution Proceeding - Direct Request.

Based on the written submissions and evidence of the applicant and in accordance with section 89 of the *Act*, I find that the Direct Request Proceeding documents were served to the tenants on February 10, 2022.

### **Issues to be Decided**

Is the applicant entitled to an Order of Possession for unpaid rent pursuant to sections 46 and 55 of the *Act*?

Is the applicant entitled to monetary compensation for unpaid rent pursuant to section 67 of the *Act*?

Is the applicant entitled to recover the filing fee for this application pursuant to section 72 of the *Act*?

### Background and Evidence

I have reviewed all written submissions and evidence before me; however, only the evidence and submissions relevant to the issues and findings in this matter are described in this decision.

The applicant submitted the following relevant evidentiary material:

- a copy of a residential tenancy agreement which names a landlord who is not the applicant and was signed by the tenants on August 2, 2017, indicating a monthly rent of \$3,600.00, due on the first day of each month for a tenancy commencing on September 1, 2017;
- a copy of an April 10 Day Notice to End Tenancy for Unpaid Rent or Utilities (the “10 Day Notice”) dated April 5, 2021, for \$3,600.00 in unpaid rent. The 10 Day Notice provides that the tenants had five days from the date of service to pay the rent in full or apply for Dispute Resolution or the tenancy would end on the stated effective vacancy date of April 20, 2021;
- a copy of a witnessed April Proof of Service Notice to End Tenancy form which indicates that the April 10 Day Notice was posted to the tenants’ door at 1:00pm on April 5, 2021;
- a copy of a May 10 Day Notice to End Tenancy for Unpaid Rent or Utilities (the “10 Day Notice”) dated May 5, 2021, for \$3,600.00 in unpaid rent. The 10 Day Notice provides that the tenants had five days from the date of service to pay the rent in full or apply for Dispute Resolution or the tenancy would end on the stated effective vacancy date of May 20, 2021;
- a copy of a witnessed May Proof of Service Notice to End Tenancy form which indicates that the May 10 Day Notice was posted to the tenants’ door at 1:00pm on May 5, 2021;
- a copy of a June 10 Day Notice to End Tenancy for Unpaid Rent or Utilities (the “10 Day Notice”) dated June 5, 2021, for \$3,600.00 in unpaid rent. The 10 Day Notice provides that the tenants had five days from the date of service to pay the rent in full or apply for Dispute Resolution or the tenancy would end on the stated effective vacancy date of June 20, 2021;
- a copy of a witnessed June Proof of Service Notice to End Tenancy form which indicates that the June 10 Day Notice was posted to the tenants’ door at 12:15pm on June 5, 2021;
- a copy of a July 10 Day Notice to End Tenancy for Unpaid Rent or Utilities (the “10 Day Notice”) dated July 3, 2021, for \$3,200.00 in unpaid rent. The 10

Day Notice provides that the tenants had five days from the date of service to pay the rent in full or apply for Dispute Resolution or the tenancy would end on the stated effective vacancy date of July 20, 2021;

- a copy of a witnessed July Proof of Service Notice to End Tenancy form which indicates that the July 10 Day Notice was posted to the tenants' door at 12:00pm on July 3, 2021;
- a copy of an August 10 Day Notice to End Tenancy for Unpaid Rent or Utilities (the "10 Day Notice") dated August 2, 2021, for \$3,200.00 in unpaid rent. The 10 Day Notice provides that the tenants had five days from the date of service to pay the rent in full or apply for Dispute Resolution or the tenancy would end on the stated effective vacancy date of August 20, 2021;
- a copy of a witnessed August Proof of Service Notice to End Tenancy form which indicates that the August 10 Day Notice was posted to the tenants' door at 1:15pm on August 2, 2021;
- a copy of a November 10 Day Notice to End Tenancy for Unpaid Rent or Utilities (the "10 Day Notice") dated November 10, 2021, for \$3,200.00 in unpaid rent. The 10 Day Notice provides that the tenants had five days from the date of service to pay the rent in full or apply for Dispute Resolution or the tenancy would end on the stated effective vacancy date of November 25, 2021;
- a copy of a witnessed November Proof of Service Notice to End Tenancy form which indicates that the November 10 Day Notice was posted to the tenants' door at 1:00pm on November 10, 2021;
- a copy of a December 10 Day Notice to End Tenancy for Unpaid Rent or Utilities (the "10 Day Notice") dated December 2, 2021, for \$3,200.00 in unpaid rent. The 10 Day Notice provides that the tenants had five days from the date of service to pay the rent in full or apply for Dispute Resolution or the tenancy would end on the stated effective vacancy date of December 20, 2021;
- a copy of a witnessed December Proof of Service Notice to End Tenancy form which indicates that the December 10 Day Notice was posted to the tenants' door at 1:00pm on December 2, 2021;
- a copy of a January 10 Day Notice to End Tenancy for Unpaid Rent or Utilities (the "10 Day Notice") dated January 2, 2022, for \$3,200.00 in unpaid rent. The 10 Day Notice provides that the tenants had five days from the date of service to pay the rent in full or apply for Dispute Resolution or the tenancy would end on the stated effective vacancy date of January 15, 2022;

- a copy of a witnessed January Proof of Service Notice to End Tenancy form which indicates that the January 10 Day Notice was posted to the tenants' door at 12:00pm on January 2, 2022; and;
- a copy of a Direct Request Worksheet showing the rent owing and paid during the relevant period.

### Analysis

In an *ex parte* Direct Request Proceeding, the onus is on the applicant to ensure that all submitted evidentiary material is in accordance with the prescribed criteria and that such evidentiary material does not lend itself to ambiguity or give rise to issues that may need further clarification beyond the purview of a Direct Request Proceeding. If the applicant cannot establish that all documents meet the standard necessary to proceed via the Direct Request Proceeding, the application may be found to have deficiencies that necessitate a participatory hearing, or, in the alternative, the application may be dismissed.

Policy Guideline #39 on Direct Requests provides the following information:

When making an application for dispute resolution through the direct request process, the landlord must provide copies of:

- The written tenancy agreement
- Documents showing changes to the tenancy agreement or tenancy, such as rent increases, or **changes to parties or their agents**
- The Direct Request Worksheet (form RTB-46) setting out the amount of rent or utilities owing which may be accompanied by supporting documents such as a rent ledger or receipt book
- The 10 Day Notice to End Tenancy for Unpaid Rent or Utilities (this is often considered proof that the tenant did not pay rent); and
- Proof that the landlord served the tenant with the 10 Day Notice to End Tenancy for Unpaid Rent or Utilities and, if applicable, the Written Demand to Pay Utilities

I have reviewed all documentary evidence and I find that the landlord's name on the tenancy agreement does not match the landlord's name on the Application for Dispute Resolution. There is also no evidence or documentation showing that the applicant is the owner of the rental property or is otherwise entitled to any orders that may result from this application.

As this is an *ex parte* proceeding that does not allow for any clarification of the facts, I have to be satisfied with the documentation presented. The discrepancy in the landlord's name raises a question that cannot be addressed in a Direct Request Proceeding.

For this reason, the applicant's request for an Order of Possession and a Monetary Order for unpaid rent is dismissed with leave to reapply.

As the applicant was not successful in this application, I find that the applicant is not entitled to recover the \$100.00 filing fee paid for this application.

Conclusion

I dismiss the applicant's request for an Order of Possession and a Monetary Order for unpaid rent with leave to reapply.

I dismiss the applicant's request to recover the filing fee paid for this application without leave to reapply.
