DECISION

Dispute Codes OPR-DR, MNR-DR, FFL

Introduction

This matter proceeded by way of an *ex parte* Direct Request Proceeding, pursuant to section 55(4) of the *Residential Tenancy Act* (the *Act*), and dealt with an Application for Dispute Resolution by the landlord to obtain an Order of Possession based on unpaid rent, to obtain monetary compensation for unpaid rent, and to recover the filing fee paid for the application.

The landlord submitted a copy of four Canada Post Customer Receipts containing tracking numbers to confirm packages were sent to the tenants by registered mail on May 13, 2022.

Issue(s) to be Decided

Is the landlord entitled to an Order of Possession for unpaid rent pursuant to sections 46 and 55 of the *Act*?

Is the landlord entitled to monetary compensation for unpaid rent pursuant to section 67 of the *Act*?

Is the landlord entitled to recover the filing fee for this application pursuant to section 72 of the *Act*?

Analysis

In an *ex parte* Direct Request Proceeding, the onus is on the landlord to ensure that all submitted evidentiary material is in accordance with the prescribed criteria and that such evidentiary material does not lend itself to ambiguity or give rise to issues that may need further clarification beyond the purview of a Direct Request Proceeding. If the landlord cannot establish that all documents meet the standard necessary to proceed via the Direct Request Proceeding, the application may be found to have deficiencies that necessitate a participatory hearing, or, in the alternative, the application may be dismissed.

In this type of matter, the landlord must prove they served the tenants with the Notice of Dispute Resolution Proceeding– Direct Request and all documents in support of the

application in accordance with section 89 of the Act. Policy Guideline #39 on Direct Requests provides the following requirements:

“After the Notice of Dispute Resolution Proceeding Package has been served to the tenant(s), the landlord must complete and submit to the Residential Tenancy Branch a Proof of Service Notice of Direct Request Proceeding (form RTB-44) for each tenant served.”

I note that the landlord submitted a copy of four Canada Post Customer Receipts containing tracking numbers to confirm packages were sent to the tenants on May 13, 2022. However, I find the landlord has not provided a copy of the Proof of Service Notice of Direct Request Proceeding forms which are a requirement of the Direct Request process as detailed in Policy Guideline #39.

Furthermore, I find that the registered mailings took place on May 13, 2022. However, the landlord did not submit their Application for Dispute Resolution to the Residential Tenancy Branch until May 17, 2022, and the Direct Request packages were not made available for service until June 1, 2022.

I find I am not able to confirm service of the Notices of Dispute Resolution Proceeding – Direct Request to the tenants and for this reason, the landlord’s application for an Order of Possession and a Monetary Order for unpaid rent is dismissed with leave to reapply.

As the landlord was not successful in this application, I find that the landlord is not entitled to recover the \$100.00 filing fee paid for this application.

Conclusion

I dismiss the landlord’s application for an Order of Possession and a Monetary Order for unpaid rent with leave to reapply.

I dismiss the landlord’s application to recover the filing fee paid for this application without leave to reapply.
